**Declares:**

- A. To be aware of the current legislation on the fight against the spread of Covid-19 and to have read the document "*Security measures for students, visitors and suppliers of the Accademia Adrianea di Architettura e Archeologia onlus*" therefore, I undertake to respect its content as well as any other rules and indications communicated by the company through my internal contacts or through billboards posted within the company premises.
- B. Not having tested positive at the Covid-19 in the 14 days preceding today's date or that in case of positivity I received appropriate certification of negativization of the buffer in the manner provided and issued by the department of prevention of territorial competence.
- C. To be aware that, in order to be able to access the Accademia Adrianea di Architettura e Archeologia onlus, I can be subjected to the detection of body temperature and if the same results equal to or greater than **37.5°** thus. I will be denied entry.
- D. To know the **obligation to use facial protection PPE** for all persons sharing common spaces. It is forbidden, within the premises of the **Accademia Adrianea di Architettura e Archeologia onlus, the use of facial masks with valve.**
- E. **That in the last 14 days:**
- i. **I have NOT had** any contact with any positive subjects at Covid-19;
  - ii. **I have NOT made** a journey to or from a foreign country, except that such provenance does not fall within one of the cases referred to in the following letter F;
  - iii. **I have NOT visited** a locality belonging to Italian Red Zone [if in the same period they have been decreed by the Government or other competent authority]
