- in view of the spread of the Covid-19 and in the light of the legislation in force, the Parties agree to subscribe to the present agreement of loyalty and correct information regarding the organization and the modalities of the "Piranesi Prix 2021" with reference to the protocols in force, the sanitary measures adopted, the responsibilities and individual behaviour aimed at containing the spread of the contagion from Covid-19.

In the light of the foregoing, the Parties, aware of all the civil and penal consequences provided for in the event of false statements, declare that:

**1) The Participant declares:**

- a. to have read and accepted all the information documents relating to the risks, the Anti-counterfeiting Protocol, the prevention and protection measures to be taken and the safety measures for students, visitors and suppliers available and downloadable from the electronic form referred to at the link <http://lnx.premiopiranesi.net/concorso-universitario/iscrizioni/> ;
- b. be aware of the measures to contain the contagion and the regulatory provisions in force (most recently the dpcm 14.07.2020 and subsequent documents);
- c. to be informed of all the organizational and hygienic sanitary dispositions for safety and for the control of the risk of spreading of the contagion from Covid-19 placed in existence from the Organizer during the "Piranesi Prix 2021", within the limits of its responsibilities; without prejudice to the responsibilities of the legal representatives of the structures used to receive the Participants;
- d. not to have tested positive at the Covid-19 in the 14 days preceding today's date or that in case of positivity has received appropriate certification of negativization of the buffer in the manner provided and issued by the department of prevention of territorial competence, or to be subjected to the quarantine measure;
- e. to have informed every subject with him cohabiting of the participation to the "Piranesi Prix 2021", the Protocols and the attached informative documentation and downloadable from the registration form;
- f. to be personally responsible to their families and/or cohabiting partners for the correct and complete information regarding what is indicated in the previous point and to the Organizer for the veracity and completeness of the statements provided;
- g. that each of his cohabitation was not positive at Covid-19 during the 14 days preceding today's date, or that, in the case of positivity, has received appropriate certification that the buffer has been negativised in accordance with the procedures laid down and issued by the Department of Territorial Prevention responsible and which is not subject to the quarantine measure;
- h. to be aware and agree to be subjected to triage (measurement of temperature and evaluation of other obvious symptoms) before access and for the duration of the "Piranesi Prix 2021", that the data will be noted and stored by the Organizer and that in the event of a temperature assessment equal or exceeding 37.5° or in the presence of other symptoms associated with Covid-19, access will be denied and immediate removal will be arranged, if the Participant is already in the structure or operating areas of relevance if outside. In the event of such situation, the Participant shall comply with the instructions set out in the Decree of the Ministry of Health provided for in Covid-19;

- i. to be aware and accept that in case of temperature equal or above 37.5 ° C, or in the presence of other symptoms also of the subjects with whom he will share accommodation in hotel facilities, will be denied access to operational areas pertaining to the "Piranesi Prix 2021" (located inside or outside the accommodation facilities) and immediate removal will be arranged, if already in the facility;
- j. be aware that, in the course of the triage procedure, it is required to inform the operator at the entrance designated by the Organizer about his state of health, in particular by declaring the existence of symptoms such as fever, respiratory distress or conjunctivitis;
- k. to be aware of having to comply with the sanitary indications provided by the Organizer and the service providers of the facilities that will host the event, which he claims to have seen.

**2) The Organizer declares:**

- a. to have provided the Participant with timely information regarding each protocol, organizational and sanitary device adopted to contain the spread of infection by Covid-19 and to commit, during the period of participation in the "Piranesi Prix 2021", when notifying of any amendments or additions to the provisions;
- b. for the implementation of the "Piranesi Prix 2021", to employ suitably trained staff on health hygiene procedures to combat the spread of contagion, with which the Organizer has entered into specific agreements concerning the commitment to scrupulously observe every sanitary prescription and the faculty to be able to carry out the educational activities only in the absence of any symptomatology related to Covid-19 and under the conditions laid down in the protocols;
- c. to undertake to implement the triage procedures at the entrance to the operational areas pertaining to the "Piranesi Prix 2021" (located inside or outside the accommodation facilities) and to adopt all the hygienic health requirements required by current legislation, including provisions on distance;
- d. to adhere strictly and scrupulously, in the case of a Participant's acclaimed infection with Covid-19, to every provision of the authority, in addition to protocols;
- e. that in case of a temperature is equal or exceeding 37,5 ° C or in the presence of other symptoms of the Participant or of the subjects with whom it will share the spaces in the accommodation facilities, is authorized to prohibit the access or the permanence of the Participant in the places where the "Piranesi Prix 2021" will take place, ordering its immediate removal.


