Failure to authorize the processing of personal and sensitive data affects the performance of the institutional activity of the Association and is therefore mandatory. Any denial of the express authorization of your data implies the impossibility of fulfilling the obligations. **The provision of data is mandatory.**

Signature

PRIVACY POLICY

Information document pursuant to and for the effects referred to in Article 13 Regulation (EU) 2016/679 (GDPR)

Following recent events related to the spread of virus infection COVID-19, the **Accademia Adrianea di Architettura e Archeologia onlus** had to undertake a series of measures to protect the health of the different individuals who access its structure, in any capacity (employees, consultants, visitors, students, etc.). The above-mentioned measures involve the processing of personal data, even special (i.e. sensitive data). For this reason, the **Accademia Adrianea di Architettura e Archeologia onlus** has provided information pursuant to Art. 13 GDPR, specific for the processing of personal data carried out for the purpose of the acquisition of data referred to in this information and the measurement of body parameters.

Attention and collaboration are required of all.

DATA CONTROLLER - Pursuant to Art. 4 and 24 of Reg. EU 2016/679 is the Accademia Adrianea di Architettura e Archeologia onlus. The Data Protection Delegate is Prof. Arch. Pier Federico Caliarì.

DATA PROTECTION OFFICER - In compliance with the provisions of Arts. 37 - 39 del Reg. UE 2016/679, the Head of Data Protection (DPO) of the **Accademia Adrianea di Architettura e Archeologia onlus** is Mrs Maria Patti.

TYPE OF PROCESSED DATA - With reference to the processing object of this information, health surveillance officers (tutors) will support Prof. Pier Federico Caliarì in the processing of the following personal data, including special (c.d. sensitive): name and surname (in case of visitor will also be detected the origin) and state of health, including the possible measurement of body temperature (c.d. fever).

PURPOSE OF TREATMENT - Protection of the health of persons who, in any capacity, access the structure of the **Accademia Adrianea di Architettura e Archeologia onlus**. For the purposes of anti-counterfeiting prevention by COVID-19, the personnel in charge will be able to measure, by means of appropriate instruments, the body temperature (c.d. fever).

The Holder states that, in the event that the body temperature should be equal to or higher than 37.5, the person concerned will not be able to access the structure or, if already present within the structure, will be removed. Faced with this situation, the person concerned will be invited to read the instructions referred to in the Decalogue of the Ministry of Health provided for the COVID-19.

LEGAL BASIS - General principles for the protection and health at work:

- Art. 6 par. 1 lett. c) legal obligation (Art. 2087 c.c. and D.Lgs. n. 81/08 Health and safety protection in the workplace) and lett. d) safeguarding the vital interests of operators who cooperate with the Data Controller and other natural persons, such as visitors.

- Art. 9 par. 2 lett. b) - to fulfil the obligations and exercise the specific rights of the Data Controller or the Data Subject in matters of labour law and social protection and social security.

DATA RETENTION PERIOD - The collected data will be stored until the end of the state of emergency.

NATURE OF THE PROVISION - The provision of data is mandatory. The refusal will make it impossible to access the **Accademia Adrianea di Architettura e Archeologia onlus**.

RECIPIENTS/CATEGORIES OF RECIPIENTS OF DATA - The personal data processed will be communicated to duly instructed subjects, whether they operate pursuant to Art. 29 or Art. 28 GDPR, whether they are autonomous data controllers. Specifically: office in charge of personnel management; in charge of workplace safety.

DATA TRANSFER TO AN EXTRA-EU COUNTRY - Personal data will not be transferred to countries outside the European Union.

RIGHTS OF THE INTERESTED PARTIES - The interested party may assert his rights, as expressed in Articles. 15 and ss. of EU Regulation 2016/679, by directly contacting the Data Controller or the DPO, the contacts listed above. In particular, the Data Subject has the right, at any time, to obtain, by the Data Controller, access to your personal data and to request information relating to the processing and to restrict their processing. If the Data Controller considers that the processing of personal data carried out by the Data Controller is in breach of the provisions of Regulation (EU) 2016/679, the Data Subject has the right to lodge a complaint with the Supervisory Authority - Italian Guarantor (<https://www.garanteprivacy.it/>).

CHANGES IN INFORMATION - The Data Controller may change, modify, add or remove any part of this Privacy Policy at any time, unless it is necessary to request the consent of the Data Subject, where applicable. In order to facilitate the verification of any changes, the information will contain an indication of the date of update of the information.
